  - Electronic Communication Meetings--(Council members John Edwards, Roger Wiley, E.M. Miller, Stewart Bryan, and Senator Houck).--  
*Background: The 2005 Electronic Meetings Subcommittee examined the feasibility of expanding the authorization for the conduct of electronic communication meetings to local public bodies and voted not to recommend HB 2760 in light of the significant relaxation of the procedural requirements made to § 2.2-3708 by the 2005 Session of the General Assembly. The Electronic Meetings Subcommittee recommended that the issue be revisited in 2006 after some experience with the new rules governing electronic meetings.*
  - Mandated Fifth Response to FOIA Requests.--*Background: this issue is a continuation from last year when we discussed whether a mandated fifth response to a FOIA request--the requested records do not exist-- was needed. It is suggested that to bring this issue to resolution, a subcommittee be created.*
  - PPTA/PPEA Subcommittee (SB 5011, 2006 Special Session)--*SB 5011 amended the FOIA exemption for PPTA/PPEA records by expanding the exemption for records prepared by public bodies used to review and negotiate PPTA/PPEA agreements. SB 5011 also expanded the open meeting exemption in*

*the case of PPTA projects. The amendments to SB 5011 will expire on July 1, 2007 in order to give the FOIA Council an opportunity to review the amendments and recommend changes deemed appropriate.*

*Susan Prokop, Chair, Statewide Independent Living Council (SILC), has expressed concern on behalf of SILC that Virginia's open meetings law have an adverse impact on the ability of people with disabilities to participate on SILC.*
